Background

In the UK there is a move towards making safety assessments, safety cases and regulatory reviews for new nuclear facilities more widely available to stakeholders, particularly those for new radioactive waste disposal facilities. Broader communication is expected to be part of the environment agencies' authorisation process for a deep repository for highly active solid wastes and new near-surface disposal facilities for short-lived and low-activity wastes. Communicating the complex and technical concepts in these assessments to non-technical audiences requires different communication skills and has implications for those involved in the preparation of these documents, as well as for the regulators.

In addition, there are lessons that the nuclear industry can learn from other industries and sectors that have built up experience in communicating complex subjects to non-technical audiences, for example in connection with climate change.

The workshop will consider both the broader context of the communication of complex subjects to non-technical audiences and the specific implications for those working in the nuclear sector. The afternoon facilitated discussion will provide an opportunity for delegates to discuss the drivers, challenges and mechanisms for successful communication in this context.

By attending you will:

- hear from experts in the field of communicating technical information to non-technical audiences
- gain an understanding of the developing UK regulatory processes for new near surface waste dis posal facilities and a deep repository
- discuss the implications of increased openness for the contractors and consultants who contribute to safety assessments and safety cases.
